For over 20 years, NeighborWorks has participated in the Department of Housing and Urban Development's (HUD) Comprehensive Housing Counseling program, serving as an intermediary to channel resources to network housing counseling agencies.



Through the NeighborWorks Center for Homeownership Education and Counseling (NCHEC), NeighborWorks provides specialized certification and continuing education for housing and financial counseling practitioners throughout the country. Since its launch in 2004, there have been nearly 200,000 NCHEC course registrations. Our Work in Action

When Estelle D'Anna purchased her home in 2019, she never imagined she would face foreclosure just over a year later. But when her daughter was diagnosed with congestive heart failure, her world was turned upside down. Like so many hardworking Americans, Estelle had no paid time off — no safety net. If she didn't work, she didn't get paid. Bills began to pile up, and she fell behind on her mortgage.



With nowhere to turn, Estelle found hope through housing counseling provided by NeighborWorks Northeastern Pennsylvania, a NeighborWorks network organization. Pamela Anslinger, the organization's director of homeownership services, helped Estelle navigate the Pennsylvania Homeowner Assistance Fund, securing not only the funds to bring her mortgage current but also six months of forward mortgage payments to help her get back on her feet.

"That was the moment I felt hope again," Estelle said.

Pamela emphasized the importance of meeting clients where they are. "We don't just work with the crisis of today. We build stronger foundations for tomorrow."

Housing Stability Counseling Program (HSCP)

In times of crisis, Congress has called on NeighborWorks America to stand up responsive emergency programs. In 2021, in response to the pandemic, Congress directed NeighborWorks to design and administer a \$100 million housing counseling grant program to assist families at risk of losing their home to foreclosure or eviction. By the time the Housing Stability Counseling Program concluded in 2024, 93,000 customers in all 50 states, the District of Columbia, Puerto Rico and Guam had received assistance. In designing the program, NeighborWorks leveraged its experience, lessons learned and best practices from the implementation of previous large grant programs, including the National Foreclosure Mitigation Counseling Program, which served over 2.1 million borrowers before concluding in 2018.
